2025 Terms & Conditions



As a condition of doing business with Treasure Garden, Inc. and its affiliates all persons involved in the commercial purchase, sale, or resale of TG products (each, a “Dealer”) shall be bound by the following terms and conditions (the “Agreement”).

Distribution:

SimplyShade believes it is in our best interest to control product distribution and support our authorized dealers. We would like to ensure that the consumers who decide to purchase our product receive the superior level of service that SimplyShade expects. To protect this reputation, SimplyShade reserves for itself the sole right to select its dealers.

To qualify as a SimplyShade retail dealer the business must:

- Reasonably accommodate purchases of anyone showing interest in SimplyShade products.
- Be moderately capable of “after the sale” service and support to the end-user and reasonably accommodating of consumer requests for such service and support.
- Retail dealers should be qualified or trained by their SimplyShade sales representative.

SimplyShade reserves the right to respond to geographic and individual market and competitive situations by applying different policies to its various dealers. SimplyShade also reserves the right to rescind or modify, at its sole discretion, any existing or future sales program or policy, or the credit terms (if any) extended to a Dealer. In addition, TG may terminate any authorized Dealer, for any reason or no reason, in its sole and absolute discretion and without notice.

eCommerce Policy:

Please refer to the Internet Agreement, which must be signed to become a dealer.

Credit Terms:

Dealer must qualify for open credit terms to be a retail dealer. We are unable to process orders on a proforma basis. A minimum annual sales volume of \$10,000 is required to stay established as an account. Allow a few days for the credit processing and approval. The Treasure Garden Inc. commercial credit application agreement begins the process of establishing a credit or billing account with SimplyShade. SimplyShade generally offers payment terms of Net 30 days (on approved credit) to an authorized retail dealer. Orders accepted by SimplyShade shall be deemed to be contracts arising within the State of California. Prompt payment is requested and must be sent to arrive by the due date. No deductions or debit memos are accepted. A service charge of one and one-half percent (1-1/2) per month or such maximum lesser rate as may be permitted by law will be assessed to all past due invoices. We also reserve the right to assess service charges on past due invoices without prior notification. Invoices are considered overdue if the payment is not received by the due date. Credit files are routinely reviewed and a current financial statement or information may be requested. We may also request assurances of your ability to pay; such request will be made in writing and we may, upon the making of such request stop production and suspend shipments. The company reserves the right to increase, reduce, suspend or withdraw open account privileges at its sole discretion at any time without prior notification. If your account is inactive for a 12 month period, your sales volume is below the \$10,000 minimum or there is a change in your business or credit status, your credit terms will be canceled. No additional notice will be given.

Prices:

MSRP Effective Date: 04/15/2025. Prices listed in the catalogue are suggested retail prices. Your cost is based on the designated dealer classification. Ask your Sales Representative for details regarding our program and pricing structure.

MAP Effective Date: 04/15/2025.

Taxes and Surcharges:

The Manufacturer’s Suggested Retail Price (“MSRP”) does not include any state tax, local tax or surcharges. California sales tax may apply to shipments made within California, picked up at our California facility or drop shipped within the state of California unless we have a CA resale certification on file. For shipments out of CA the appropriate sales taxes will be added to acknowledgements or invoices unless we are provided with a valid State sales tax exemption certificate. Sales taxes will be added based on the address where the product is being shipped to. Treasure Garden, its dba Shademaker, SimplyShade have a presence in 39 states. We collect sales tax in our nexus states. As of JUNE 2022, these states are AL, AR, AZ, CA, CO, CT, DC, FL, GA, IA, ID, IL, IN, KS, KY, LA, MA, MD, ME, MI, MN, MO, NC, NE, NJ, NM, NV, NY, OH, OK, PA, RI, SC, TN, TX, UT, VA, WA & WI Please note that CA, CT, DC, MA & MD will NOT accept another states resale certification or resale number for tax exempt purposes.

2025 Terms & Conditions



Order Procedures:

To ensure that your order is processed without delay we require:

- A written purchase order (no phone orders) from an authorized buyer including the business name, account number, phone number and purchase order number.
- Ship date and specific shipping instructions. If you request freight collect or 3rd party billing, please provide the account number.
- Our item/style number, fabric number, type and color
- Quantity of each style
- Customer's name on all Special Orders

Please note that any discrepancies can cause significant delays. We ask that you review the acknowledgment for accuracy and advise SimplyShade immediately of any discrepancies or changes. We reserve the right to hold any order from production, pending signed acceptance of the pricing on our order acknowledgement. Lead time starts once order is finalized.

Freight Charges:

The shipping charges on your invoice may differ from those on your acknowledgement. This is largely due to instability in today's fuel economy. Please understand that these charges are assessed by the carrier, not SimplyShade. These charges can sometimes include fuel surcharges, lift gate, extra delivery charges, as well as standard pallet fees (up to and in excess of \$39 each), box pallet fees (up to and in excess of \$45 each) which may not have been indicated on the preliminary freight quotes. The pallet fees may increase depending on the cost of these items.

If the freight charges are prepaid & added to your invoice, the shipping charges may include any applicable pallet charges. To ensure the most economic freight for our customers, we are constantly reviewing freight rates. If we ship your orders freight collect or 3rd party billing we will bill your company for any applicable pallet charges.

Changes/Cancellations:

Changes and/or cancellations of product or shipping dates must be received at our office within 24 hours of the acknowledgement date. NO EXCEPTIONS. Orders that do not follow these guidelines will be charged a 25% restocking or handling fee. We cannot guarantee that purchase orders added to an existing order will be shipped together. If items are added to an order or an item on an order is changed, the entire order may be rescheduled as of the date of the change. This may result in a later ship date than the original order. In the event an order is refused and/or returned to us, a 25% restocking/handling fee may be assessed in addition to the inbound and outbound freight charges.

Back Order/Partial Shipments:

Due to the considerable number of items we offer, we may not initially be able to ship or deliver your entire order. In such event the balance and/or entire order thereof will be back-ordered and shipped and delivered at a subsequent time or times. Standard shipping charges will apply to partial or back order shipments.

Shipments:

IN-SEASON: Our goal is to ship IN SEASON orders within the specified lead times.

3 Business Days: Specialty, Market & Accessories

5 Business Days: Cantilevers

Large quantities may result in partial shipments. This is a goal, not a guarantee - and may be slightly affected by availability of fabrics & consumer demands.

ALL SHIPMENTS - SimplyShade shall, in the event of no routing instructions from the buyer; select a carrier, which it feels, can adequately handle each shipment.

Order Scheduling:

Deliveries are subject to fire, storm, flood, war, rebellion, riot, strike or labor trouble, interruptions to transportation, perils of navigation, damage to factory, equipment of facilities, governmental mandates, including the exercise of acts of God, failure of our sources of supply in whole or in part, and other cause beyond our control. We shall not be liable for any damages or failure to deliver or delay in delivery due to any such causes. If possible we will attempt to ship merchandise the week of the requested ship dates. However, in order to maintain an orderly schedule, we reserve the right to schedule the merchandise shipment to the nearest available production schedule and to ship accordingly. Our regular business days are Monday through Friday.

2025 Terms & Conditions



Freight Claims:

All merchandise is delivered to the carrier in factory new condition. Our FOB shipping points are Baldwin Park, CA, Surprise, AZ or Ningbo, China. The FOB location depends on your order type and product availability. The carrier accepts responsibility for the safe delivery upon acceptance of the shipment. SimplyShade should be notified immediately regarding any claims. Claims for loss or damage sustained in transit must be filed by the Dealer, as follows:

Visible Damage:

It is the Dealer's responsibility to check the merchandise and file a claim with the carrier if the shipment was made using the dealer's carrier and account. Request a claim form from the delivering carrier and file your claim immediately. If the shipment was made using SimplyShade's carrier and account, it is the Dealer's responsibility to check the merchandise and notify SimplyShade immediately of the situation so that a claim can be filed. In either situation, make a notation on the Bill of Lading as to the nature and extent of the damage and obtain a signature of the carrier's agent. (Failure to adequately describe this information may result in the carrier refusing to honor the claim and SimplyShade will not, under any circumstances, be liable for damage sustained in transit).

Concealed Damage:

If damage is discovered when unpacking the merchandise, immediately mark the damaged area and submit a written request for the carrier to inspect. Attach a copy of the concealed damage information. Do not remove the merchandise from the original carton until the carrier inspection is complete. If the merchandise was shipped using SimplyShade's carrier and account, it is the Dealer's responsibility to notify SimplyShade immediately of the situation so that a claim can be filed. Concealed damage needs to be reported and claim filed within 5 days for all carriers.

Shortage:

It is the Dealer's responsibility to inspect all merchandise and to file claims with the carrier in the event of product shortage. Make a notation on the Bill of Lading as to the number of cartons short. SimplyShade must also be notified immediately of any shortages. File the claim with the delivery carrier immediately. No claim for shortages, damaged items or errors will be honored unless it is made in writing on the Bill of Lading immediately upon receipt of the shipment. Notwithstanding anything to the contrary in this Agreement, failure to make a claim on the Bill of Lading will constitute a waiver of any rights to a refund or credit.

Return Goods:

No returns will be accepted without a written Return Authorization (RA#) from the factory. It is the Dealer's responsibility to follow routing instructions. Please fax in a request for an RA#. Your request must include the following information:

- Company name, contact name, number & store hours;
- The SimplyShade invoice and/or acknowledgement;
- The item no., number of units to be returned and carton total;
- The reason for the return; and
- Which carrier will be returning the goods and the date of the shipment.

Any item that is returned for credit that is not under SimplyShade's warranty policy is subject to a 25% restocking fee (and must be properly packaged) plus inbound and outbound freight charges, if applicable. Any item that is returned for repair or replacement that is not under SimplyShade's warranty policy is subject to the applicable repair charges listed in the "Other Fees" section, below. Per the SimplyShade Limited Warranty, SimplyShade restricts warranty service for SimplyShade products to the country where SimplyShade or its authorized SimplyShade retail Dealers originally sold the product.

Errors:

There may be errors in the prices, descriptions or images of certain merchandise in our catalog or sales material. We reserve the right to restrict orders of those items.

Other Fees:

These fees apply to both contract accounts and retail dealers.

- Non-warranty repairs are subject to a labor charge of \$50 per hour plus applicable parts, inbound and out bound freight charges. Please allow at least 5 business days for processing.
- A \$25 service charge will be assessed on any returned check.
- Pallet fees, residential delivery fees, lift-gate fees, limited access and "call before delivery" fees vary depending on the carrier.
- A Materials Handling Fee may be assessed for palletized orders shipping LTL freight collect or when special labels are required to print for each order.

Shipping:

Most SimplyShade products can be shipped using parcel companies (UPS, FedEx, or other). Some of our larger or heavier products however, must be shipped with a trucking company. Such products are identified with the “Truck Only” icon. SimplyShade can only ship to addresses in the US and Canada. If shipping to Canada, you must have your own broker to clear items through customs and this information must be provided with the purchase order.

Payments:

Payment will be accepted in US Dollars only. If payment is paid by a standard business check from a Domestic bank institution, please allow 2-5 business days from our deposit date for your funds to clear. Invoice payments should be mailed prior to the due date and sent to our corporate office in Baldwin Park, CA. Payments made in a different manner may be delayed.

Pricing:

“MSRP” means the Manufacturer’s Suggested Retail Price as set forth in this Catalog. “MAP” means the Minimum Advertised Price as set forth in this paragraph. Dealers must adhere to MAP requirements when advertising via any traditional media, in all online advertising, online comparison price shopping, and landing pages. Dealers cannot advertise SimplyShade products below a published Net MAP price list effective the start of each fiscal year. SimplyShade reserves the right to adjust MAP pricing based on MSRP changes due to tariff implementation and/or other unforeseen market conditions, as needed during the fiscal year. This net pricing is inclusive of, but not limited to, discounts such as coupons, promo codes, email “sign up” discounts and sales tax. In addition, no advertisements may state or otherwise suggest that the SimplyShade MSRP is higher than the actual MSRP as set forth in this catalog. It is also incumbent on all dealers to update their online pricing on February 1st of each year to reflect any changes to MSRP and MAP that might occur. Minimum Advertised Price Requirements:

The Dealer agrees that money damages or other legal remedies would not, standing alone, be a sufficient or adequate remedy for any breach or violation of the MAP requirements. As such, in addition to all other remedies available to SimplyShade, SimplyShade shall be entitled to an injunction restraining such breach or violation and to other equitable relief, including specific performance, without a bond or other security being required. Product Advertising:

Bulk Sale and Third Party Restrictions:

If a Dealer decides to resell product to a third party said Dealer is responsible for any warranty or service issues, as well as is still bound to this agreement. The third party is not under agreement with SimplyShade, it is the Dealer that is doing business with SimplyShade.

Duty to Notify SimplyShade of Complaints:

Dealers shall make a careful and thorough inspection of all goods received. Subject to and without limitation of the requirements of the “Freight Claims” section above, Dealers must notify SimplyShade in writing of any complaints or issues, whether existing or reasonably foreseeable, relating to SimplyShade’s performance including, but not limited to, discrepancies in quantity or description of items delivered, defects or potential defects in items delivered, or any other issue whatsoever relating to SimplyShade’s performance (except issues relating to billing disputes, which are dealt with in the next section.) Notice shall be provided to SimplyShade within 30 days of: (i) the Dealer’s receipt of any defective or non-conforming goods, or (ii) the time any other issue complained of came, or should, with reasonable care, have come to Dealer’s attention – whichever is earlier. Unless timely notification is received by SimplyShade in accordance with the terms hereof, which notice shall identify with particularity all complaints or issues asserted by the Dealer, the Dealer irrevocably waives any and all complaints relating to any defective or non-conforming product or any other issue whatsoever relating to SimplyShade’s performance and the Dealer shall have no recourse against SimplyShade. The Dealer shall be solely responsible for retaining proof that the written notice required by this section was received by SimplyShade.

Payment Obligations:

Dealers agree to examine immediately upon receipt each of SimplyShade's statements of account, invoices, or other billing statements (collectively, "Bills"), and to notify SimplyShade in writing of any disputed Bills within 10 days of receipt. Such disputes may include, but are not limited to, disputes relating to charges for items that were billed but not received; charges for product that was received but not ordered; or charges for items that were returned, refused, credited, or have a freight claim pending. Dealers will not withhold payment when disputes arise. Only the disputed portion of a timely disputed past-due balance may be withheld. Unless timely notification is provided to SimplyShade in accordance with the terms hereof, which notice shall identify with particularity any and all objections to any of SimplyShade's Bills, the Dealer irrevocably waives any and all objections to SimplyShade's Bills. In addition, the Dealer agrees that its obligation to pay SimplyShade is separate and independent from any obligations SimplyShade may have to the Dealer. In the event the Dealer fails to pay SimplyShade in accordance with the terms hereof, the Dealer irrevocably waives the right to assert any and all claims, offsets, or any other defenses whatsoever to SimplyShade's right to payment. The Dealer further agrees that any payments to SimplyShade may be applied to any invoices or other indebtedness owed to SimplyShade, in SimplyShade's sole and absolute discretion. The Dealer shall be solely responsible for retaining proof that the written notice required by this section was received by SimplyShade.

Statements are sent on the 1st business day of each month and mid-month.

Attorneys' Fees:

The Dealer agrees that it shall be liable for all of SimplyShade's attorneys' fees (including local counsel fees), experts' fees, accountants' fees, court fees, collection costs, collection agency fees (if applicable), and any other expenses, whether or not incurred in connection with litigation or arbitration, arising from the breach of any term of this agreement by the Dealer, and/or in connection with the enforcement of any judgment or award rendered in favor of SimplyShade.

Governing Law:

You agree that all matters relating to your purchase and use of SimplyShade products, including all disputes, will be governed by the laws of the United States and by the laws of the State of California without regard to its conflicts of law provisions. You agree to the personal jurisdiction by and venue in the state and federal courts in Los Angeles County, California, and waive any objection to such jurisdiction or venue.

No Waiver:
